Provide your perspective on freight needs and learn about how freight is key to New Hampshire's economy and quality of life.
- **Freight Operations & Logistics: Private Sector Insights & Perspectives** – Hear from Oscar DeVlaminck, President, and Adam Manley, Director of Operations, of Demanko HLC Logistics, Inc. as they share their insights regarding the impacts of policies and technologies on freight mode choices and logistics in the private sector.
- **The Economics of Autonomous Trucking** – Hear about some of the latest developments and insights for autonomous trucking in the private sector from Dale Lewis, Former VP Finance, AVP Trucking, & Director of Strategic Analysis for CSX Corp. Learn how autonomous trucks could improve the delivery of goods and lower shipper cost. Discuss how this shift would impact the state and local roadway networks. In this talk, also presented in April for MIT's Freight Lab Speaker Series, Mr. Lewis will explore a range of driver cost, fuel tax, and truck equipment cost scenarios.
